Workshops at Regional Conference

he Delta Foundation has several workshops planned for the various regional conferences being presented this summer by Delta Sigma Theta Sorority, Inc. The Foundation, in collaboration with the Sorority's National Arts and Letters Commission, will launch its National Reading Circle at the Southern Regional Conference in Huntsville, AL June 25-28, 2009.

The National Reading Circle, a program under the auspices

of the Foundation's Center for Research on African American Women, will debut with Paula J. Giddings, award-winning author and professor at Smith College, as the featured author. Paula will give a talk about her latest work, *IDA: A Sword Among Lions* (Harper Collins, 2008), a biography on Ida B. Wells and the antilynching movement. The reading circle will also be presented at the Central,

he Delta Research and Educational Foundation (The Delta Foundation) presented a special political awareness program entitled "Coffee and Conversation with Our Congresswomen" on March 2, 2009 at the Gaylord National Resort and Convention Center. The program was held in collaboration with the Social Action Commission of Delta Sigma Theta Sorority and its 20th Annual "Delta Days in the Nation's Capital" legislative conference. More than 1,000 guests were afforded the opportunity to hear conversational dialogue, addressing political issues and legislative affairs.

from three U.S. Congress-women: Yvette D. Clarke (D-NY), Donna Edwards (D-MD), and Marcia L. Fudge (D-OH). Keeping the dialogue flowing was program moderator, April D. Ryan, White House News correspondent for American Urban Radio Networks.

Delta Foundation President Alison J. Harmon, Ed.D., stated that the program was presented to provide a platform where African American women could hear directly from female congressional representatives—without a mass media filter—about weathering the current eco-

nomic decline, ensuring quality education for youth, and how to impact the legislation presented during the 111th Congress that benefit America's communities

The congresswomen gave updates on legislation from their respective committee assignments and answered question from the audience. Congresswoman Clarke is a member of three House committees and two subcommittees within each committee: Education and Labor, Homeland Security, and Small Business. A woman of Caribbean heritage who represents New York's 11 Congressional District, she passionately expressed that she aims to bring great sensibility and sensitivity to persons immigrating to America. Congresswoman Donna Edwards of Fort Washington, MD, represents Maryland's 4th Congressional District. She currently serves on the Transportation and Infrastructure Committee, Science and Technology Committee and three subcommittees within those committees. Congresswoman Edwards encouraged Deltas to learn about the numerous job opportunities that may be created by the "greening of America" (conservation). Congresswoman Fudge, representing Ohio's 11th Congressional District, is a member of the Education and Labor Committee and the Science and Technology Committee. A past national president of Delta Sigma Theta Sorority, Inc. and a former National Co-Chair of the Social Action Commission, Congresswoman Fudge urged the Delta Days participants to seek funds from the Recovery Act to help improve their local communities.

The announcement establishing the Stephanie Tubbs Jones Institute for Social Change was also made by Dr. Harmon at the "Conversation" program. The Foundation presented a video tribute to Congresswoman Tubbs Jones who died in 2008.

Foundation Establishes Sister Scholars' Advisory Council for Research Center

The Delta Research and Educational Foundation recently established the Sister Scholars' Advisory Council to provide counsel for the Center for Research on African American Women (The Center). The first meeting of the Council was held on April 24th at The Center, located at the Foundation office in the Delta Sigma Theta Sorority, Inc. National Headquarters complex. The meeting was chaired by Julie Richie, Foundation board of directors member who chairs the program planning and research committee.

The Center was established in 1997 by the Foundation and the Sorority to serve as a resource center and repository to

examine the complex factors influencing African American women's lives. Research findings have been released through the Center's Annual Forum or published in The Center's scholarly journal.

Delta Foundation President Alison I. Harmon identified African American women scholars who would lend their expertise to moving The Center's agenda forward. Attending the first meeting of the Council and having agreed to serve as a Sister Scholar are Dr. Ramla Bandele, a political economist at Indiana University-Purdue University; honorary Delta member, Dr. Darlene Clark Hine, professor of African American Studies and history at Northwestern University; and Delta members: Dr. Elizabeth Clark-Lewis, professor of history at Howard University; Dr. Cynthia Neverdon-Morton, professor of history at Coppin State University; and Dr. Celeste Watkins-Hayes, assistant professor of sociology and African American Studies at Northwestern University. Two additional Delta members agreeing to serve on the Council, but were unable to attend the meeting were Paula J. Giddings of Smith College and Dr. Mary Frances Berry of the University of Pennsylvania.

Local chapters of Delta Sigma Theta Sorority, Inc. and community organizations that share similar goals and missions as those of the Sorority, and The Delta Foundation are invited to apply for the annual

program grant awards. The local community organizations (non-Delta Chapters) that apply must have the 501 (c)(3) status, granted by the Internal Revenue Service. Program grants up to \$1,000 will be awarded.

While we understand the critical need for direct services, The Delta Foundation

supports community service-based programs. During fiscal year 2008-09, 18 program grants were awarded: 12 Delta chapters and 6 community organizations. Delta chapters and collaborative partners (community organizations) are encouraged to submit grant applications.

The grant application and guidelines will be posted on the Foundation's website (www.deltafoundation.net) beginning July 1, 2009. The deadline for submitting the application is October 1, 2009. Applicants must address one or more elements of the Sorority's Five-Program Thrusts in their grant request, clearly stating how the proposed project will impact issues affecting African American women and their families. The programmatic thrusts include: Economic Development; Educational Development; International Awareness and Involvement; Physical and Mental Health; and Political Awareness and Involvement.
